

MINUTES of the Disciplinary Committee Meeting of the Middlesex County Football League held on Monday 03 November 2008 at Brookhouse FC, Farm Park, Kingshill Avenue, Hayes, Middx at 8-50 pm.

Reason : To update all outstanding matches relating to discipline, each item was dealt with individually and after discussion the following decisions were forthcoming :-

13 Sept Div 1 (C&E) FC Team v Blue Marlin FC Team did not have enough registered player under Rule 8(F)(ii). Match awarded to Blue Marlin, FC Team fined as per Rule.

13 Sept Div 1 (W) CB Houns Utd v North Kensington North Kensington played an unregistered player under Rule 8(Q)(i). Defer to Dec meeting still searching for continuation list .

20 Sept Sen.Res.Div. Feltham Res v North Kensington Res Feltham Res played an unregistered player under Rule 8(Q)(i). Match awarded to North Kensington Res, Pts deducted from Feltham Res, -3 pts, fined as Rule.

20 Sept Sen.Res.Div. Hillingdon Res v Renegades Res Hillingdon Res played an unregistered player under Rule 8(Q)(i). Match awarded to Renegades Res, Pts deducted from Hillingdon Res, -3 pts, fined as Rule.

27 Sept Div 3 (H&D) AFC Heathrow v West London Saracens West London Saracens played an unregistered player under Rule 8(Q)(i). Match awarded to AFC Heathrow, Pts deducted from WLS, -3 pts, fined as Rule.

27 Sept Div 2 LPOSSA v Junior All Stars Mix up on return of registration cards, cards sent to wrong address. Match to be rescheduled.

04 Oct Div 1 (C&E) Hendon A v London Utd Football Assoc. Hendon A unable to field a side as players taken to make up first team. Rule 10(F)(i) Match awarded to L.U.F.A., Hendon A -3 pts, fined as Rule.

11 Oct Div 1 (W) North Kensington v Harrow St Marys Referee appointed Sat. morning, turned up, nobody at the ground. Request written explanation from both teams, defer to Dec meeting.

11 Oct Div 2 Warren v Renegades Game not played. Renegades possibly withdrawing first team from the League, defer decision to Dec meeting.

11 Oct Div 3 (H&D) ASW v AFC Heathrow Away team accident on way to match, no explanation given. Request written explanation from AFC Heathrow, defer to Dec meeting.

11 Oct Sen.Res.Div. Tokyngton Res v Hayes Gate Res Tokyngton Res failed to field a side. Rule 10(F)(i) Match awarded to Hayes Gate Res, Tokyngton Res -3 pts, fined as Rule.

18 Oct Div 1 (W) Harrow St Marys v CB Houns Utd Social Game abandoned. Request written explanation from both teams, defer to Dec meeting.

18 Oct Div 2 The Wanderers v Warren Game postponed, no referee. Match to be rescheduled.

25 Oct Div 1 Cup My Generation Sports v Blue Marlin Game abandoned (5 mins to play) MGS player spat at the Referee. MGS at fault, game awarded to Blue Marlin, defer further decision until after County decision.

25 Oct Div 3 (H&D) AMU v AFC Ashford AFC Ashford failed to turn up. Request written explanation from AFC Ashford, defer to Dec meeting.

25 Oct Div 2 Fulham Dynamo Sports v Maiwand Game abandoned, Maiwand had 5 players sent off (30 mins to play). In hands of London FA, Referee reported for racism, defer to Dec meeting.

25 Oct Sen.Res.Div. Kodak Res v Tokyngton Res Tokyngton Res unable to field a side, Rule 10(F)(i) Match awarded to Kodak Res, Tokyngton Res -3 pts, fined as Rule.

Appeal by The Wanderers against the doubling of their fines, entered under Rule 15 with the appropriate fee, dismissed as fines had been doubled because the original fines had not been paid within the 14 days as per Rule 5(I)(i) although they had been notified correctly followed also by a reminder telephone call.
